### 2014 GOLD PLAN PRE-PAY

Pre-pay for your 2014 Maintenance Program in Full by February 15, 2014 and receive a credit toward your next Brunetti Pools service, repair or chemicals.

Program #1 - \$300 Credit    Program #2 - \$250 Credit    Program #3 - \$200 Credit

## 2014 Maintenance/Service Programs

**#1. Weekly Pool Maintenance    \$2,395 (+7% NJ Sales Tax)    Total: \$2,562.65**

- Pool summerization with cover removal. Shock treat pool water.
- Initial pool vacuum (included and performed 2-3 days after the pool opening).
- 18 weekly maintenance visits.
- Chemicals\*\* (see terms and conditions for inclusions and exclusions).
- Pool winterization using Owner's cover.

**#2. Bi-Weekly Pool Maintenance    \$2,165 (+7% NJ Sales Tax)    Total: \$2,316.55**

- Pool summerization with cover removal. Shock treat pool water.
- Initial pool vacuum (performed 2-3 days after the pool opening).
- 9 weekly maintenance visits. (pool vacuum every other week).
- 18 weeks of water testing and balance chemistry.
- Chemicals\*\* (see terms and conditions for inclusions and exclusions).
- Pool winterization using Owner's cover.

**#3. Weekly Chemical/Water Balance Maintenance    \$1,750 (+ 7% tax)    Total: \$1,872.50**

- Summerization with cover removal. Shock treat pool water.
- Initial pool vacuum (included and will be performed 2-3 days after the pool opening).
- 18 weeks of water testing and balance chemistry.
- Chemicals\*\* (see terms and conditions for inclusions and exclusions).
- Pool winterization using Owner's cover.

**#4. Pool Summerization    \$225 (+ 7% NJ Sales tax)    Total: \$240.75**

**(This Program is not eligible for pre-pay credit)**

- Reassemble and start filtration.
- Install skimmer baskets, ladders and grab rails.
- Add DE if required.
- Shock treat pool water.
- Test fire heater (heaters will be shut down after a 5 minute run time).
- Rinse pool decks, chlorine wash coping and brush tile line.
- Cover must be removed by owner and water brought up to normal operating level BEFORE our arrival.

**#5. Pool Summerization and Cover Removal    \$325.00 (+ 7% NJ Sales Tax)    Total: \$347.75**

**(This Program is not eligible for pre-pay credit)**

- Includes all items in Pool Summerization Program #4.
- Remove and fold cover.
- Owner responsible for pool cover to be pumped dry and free of all debris and water brought up to normal operating level BEFORE our arrival.

## Terms and Conditions

### **\*\*Included chemicals for programs 1,2 and 3.**

- Up to 400 lbs. pool salt (8 bags). Salt required for spring start up will be used from this allotment.
- Up to 25 lbs. Tri-chlor tablets for non-salt pools.
- Up to (6) 6lb. DE filter charges for after backwashing.

### **\*\*Excluded Chemicals for Programs 1,2, and 3 to be billed on a monthly basis.**

- Alkalinity sodium bicarbonate \$2.50 per lb.
- Muriatic acid \$10 per gallon (used to lower pool pH).
- Chlorine shock \$4.25 per lb. (for super chlorination).
- Liquid chlorine \$5 per gallon (to clean decks and to increase pool chlorine residual).
- PhosFree \$41.46 per bottle (to lower phosphates and keep phosphate levels low).
- PhosFree/Pool Perfect 3L bottle \$54.36 (a weekly treatment recommended for all pools).
- ScaleFree \$35.53 per bottle (a water additive to lessen efflorescence on glass tile and natural stone).
- Stain and Scale \$20 per qt. bottle (an additive that keeps metals from staining pool surface).
- Algacide Pro 60 \$26.79 per qt. Bottle.
- Calcium Hardness \$2.25 per lb. (to increase the hardness of pool water).
- Cyanuric Acid (Chlorine Stabilizer) \$5.25 per lb. (stabilizes the chlorine residual).

### **Items billed after allotment is exceeded.**

- Salt \$15 per 50lb. Bag.
- Tri-chlor tablets (for non Salt Pools) \$2.50 per tablet (sanitizer for non-salt pools, slow dissolving).
- DE (Diatomaceous Earth) \$12 per backwash filter recharge.

### **Maintenance Visits include:**

- Test water chemistry and add chemicals as needed. (Chemicals used that are not included or exceeding the seasonal allotment will be billed additionally on a monthly basis).
- Vacuum pool, brush steps and benches. Programs 1 & 2 only.
- Empty skimmer baskets, pump strainer and pool cleaner bag.
- Leaf net pool surface and brush tile line as required.
- Blow off pool deck.
- Any required repair or additional service will be scheduled and billed as a separate service. Non-warranty service will be billed at a rate of \$105/hr (technician rate) plus parts and tax.

### **Additional charges not included in our maintenance programs:**

- Safety cover cable systems - assembly for closings, and removal of cables for openings. \$35 per cable per seasonal service.
- Auto fill systems. Winterization and spring recalibration. \$15 per seasonal service.
- Additional water feature pumps winterizing and reassembly \$25 per pump per seasonal service (cleaner booster pumps included in maintenance program)
- Spa Winterization and spring start up \$45 per seasonal service.

**Please Note:** Programs #4 and #5 ***do not*** include vacuuming at the time of Pool Opening. Pools must to be brought up to their normal operating level and should circulate for a minimum of 48 hours before a vacuum service can be properly performed. ### **Payment Terms:**

- To take advantage of our Pre-pay Credit for Programs #1, #2, or #3, Full Payment is due by Feb. 15, 2013.
- Programs #4 and #5 are not eligible for the Prepay Credit.
- If you choose not to take advantage of our Pre-pay Credit Option, Programs #1, #2, and #3 will require 50% payment due by March 15, 2013 and balance due in full by August 1, 2013.
- ***Additional maintenance calls beyond the 18 week Programs will be billed upon scheduling of pool closing.***
- Additional service or repairs not covered in the scope of the maintenance program will be billed separately upon completion.

**Owner Responsibilities:**

*PLEASE ENSURE THE FOLLOWING ARE COMPLETED PRIOR TO YOUR SCHEDULED OPENING (to avoid additional labor charges).*

- Schedule your Pool Opening at least 10 days before you anticipate swimming.
- Please unlock gates, remove pets and pet debris from yard.
- Ensure outdoor electric and water are turned on.
- All pool accessories are left poolside or accessible (skimmer baskets, ladders, etc).
- Pool covers must be free and clear of water and debris. (add'l fee of \$50 per half hour for our technicians to remove water and debris from Pool Covers).
- Water level must be brought up to operating level (\$75 return trip will apply).
